

SUBJECT: - GRANT OF RESIDENCE ORDERLY / ORDERLY ALLOWANCE TO BPS-20 AND ABOVE OFFICERS OF SINDH GOVERNMENT.

I am directed to refer to this Department's circular letter No. FD (SR-III) 5 / 22 – 85 (Provl), dated 10<sup>th</sup> March, 2008 on the subject noted above and to state that with the approval of the competent authority, i.e. Chief Minister Sindh, it has now been decided to extend said facility to all Officers in BPS-20 and above working under Sindh Government to either retain residence orderly or receive Rs.3000/- (Rupees Three Thousand) only, with effect from 01<sup>st</sup> July,2009 as an orderly allowance on the terms and conditions stipulated under circular No. (SR-III) 5 / 22 - 85, dated 10<sup>th</sup> February, 1986 for grant of said allowance which will continue to be applicable.

2/- Further these orders will also be effective from the 01<sup>st</sup> July, 2009 in the case of those Officers who are waiting for posting and O.S.Ds in BPS-20 & above.
